Racial Integration in the United States Oxford University Press** Contemporary debate over the legacy of racial integration in the United States rests between two positions that are typically seen as irreconcilable. On one side are those who argue that we must pursue racial integration because it is an essential component of racial justice. On the other are those who question the ideal of integration and suggest that its pursuit may damage the very population it was originally intended to liberate. In *An Impossible Dream?* Sharon A. Pursuing integration against a background of persistent racial injustice might well exacerbate black suffering without any guarantee of achieving racial justice or a worthwhile form of integration. As long as the future of integration remains uncertain, its pursuit can neither be prescribed as a moral obligation nor rejected as intrinsically indefensible. International Women's Year The Greatest Consciousness-Raising Event in History Oxford University Press Amid the geopolitical and social turmoil of the 1970s, the United Nations declared 1975 as International Women's Year. The capstone event, a two-week conference in Mexico City, was dubbed by organizers and journalists as "the greatest consciousness-raising event in history." The event drew an all-star cast of characters, including Soviet cosmonaut Valentina Tereshkova, Iranian Princess Ashraf Pahlavi, and US feminist Betty Friedan, as well as a motley array of policymakers, activists, and journalists. *International Women's Year*, the first book to examine this critical moment in feminist history, starts by exploring how organizers

juggled geopolitical rivalries and material constraints amid global political and economic instability. While participants expressed dismay at levels of discord and conflict, Jocelyn Olcott explores how these combative, unanticipated encounters generated the most enduring legacies, including women's networks across the global south, greater attention to the intersectionalities of marginalization, and the arrival of women's micro-credit on the development scene. This watershed moment in transnational feminism, colorfully narrated in *International Women's Year*, launched a new generation of activist networks that spanned continents, ideologies, and generations. **Functional Structure from Top to Toe The Cartography of Syntactic Structures Oxford University Press** This volume consists of nine original chapters on central issues in theoretical syntax, all written by distinguished authors who have made major contributions to generative syntax, plus an introductory chapter by the editor. Dedicated to Tarald Taraldsen, the collection reflects the diverse energies that have pushed the cartographic program forward over the last decade. The first three papers deal with subject extraction, the que/qui alternation, and relative clause formation. Luigi Rizzi presents arguments that subjects are 'criterial' and that subject extraction is highly restricted. Hilda Koopman and Dominique Sportiche concur, suggesting that what appears to be subject extraction in French has been misanalyzed, and involves a relative structure. Adriana Belletti shows that children avoid using object relatives, preferring subject relatives, even when it requires passivization. The fourth paper, by Ian Roberts, analyzes the loss of pro-drop in the history of French and Brazilian Portuguese. The papers by M. Rita Manzini and Richard S. Kayne both present novel analyses of complementizers, suggesting that they are essentially nominal, rather than verbal. The final three papers address the relationship of morphology to syntax. The first two argue for a syntactic approach to word formation, Guglielmo Cinque's in a typological context and Anders Holmberg's within an analysis of Finnish focus constructions. The final paper, by Edwin Williams, presents an argument for the limitations of the syntactic approach to word formation. **Pseudomonas Springer** *Pseudomonas* comprises three volumes covering the biology of pseudomonads in a wide context, including the niches they inhabit, the taxonomic relations among members of this group, the molecular biology of gene expression in different niches and under different environmental conditions, the analysis of virulence traits in plants, animals and human pathogens as well as the determinants that make some strains useful for biotechnological applications and promotion of plant growth.
